The Ministry of Foreign Affairs of the Republic of Zambia presents its compliments to All Diplomatic, Consular and Trade Missions and International Organisations accredited to the Republic of Zambia and has the honour to advise that in responding to the evolving COVID-19 pandemic and in line with the decision to open Zambia's International Airports, the Government through the Ministry of Health has revised the COVID-19 screening procedures at all International Airports.

In this regard, please, find attached hereto, the Revised COVID-19 Screening Procedures at International Airports and share with all relevant stakeholders. The revised guidelines take effect from Monday, 27th July, 2020. The overall intention remains to manage travel to Zambia in order to curb further importation of the virus.

Please, note that the guidelines will be implemented taking due consideration of the provisions of the Vienna Convention on Diplomatic Relations in respect of the Diplomatic Corps.

The Ministry of Foreign Affairs of the Republic of Zambia avails itself of this opportunity to renew to All Diplomatic, Consular and Trade Missions and International Organisations accredited to the Republic of Zambia the assurance of its highest consideration.

GUIDANCE ON COVID-19 AIRPORT SCREENING PROCEDURES
AT INTERNATIONAL AIRPORTS

1.0 Introduction

Zambia has four international airports namely Kenneth Kaunda International Airport (KKIA) in Lusaka, Simon Mwansa Kapwepwe in Ndola, Harry Mwanga Nkumbula in Livingstone and Mfuwe in Mambwe district. In the light of the re-opening of the airports as guided by the Presidential directive of 25 June 2020, the following shall apply:

2.0 Documentation

Travelers' Health Questionnaires will be provided, through the office of the airport manager, to all airlines entering Zambia. These will be pre-filled on board the aircraft. After disembarkation, these forms will be surrendered to health staff at the airport for review. Staff will review traveler's cards and check completeness of entries on the Travelers Health Questionnaire focusing on contact details such as address and telephone numbers.

3.0 Entry Screening

Entry screening will be conducted at all airports. All travelers entering the airport will be subjected to temperature and symptom screening.

4.0 Testing

All travelers coming into the country through the international airports will be required to provide a negative SARS CoV-2 PCR test result. The test should have been conducted within the previous 14 days. Travelers not meeting this requirement will not be allowed into the country. Quality Assurance testing for SARS CoV2 using nucleic acid based testing platform may be conducted on randomly selected passengers presenting these negative results.

5.0 Symptomatic travelers

The following category of travelers will be tested for SARS CoV2 at the airport:

- i. All passengers with body temperature equal to or above 38°C
- ii. All passengers with body temperature equal to or above 38°C and any one of the following symptoms: cough, shortness of breath or difficulty in breathing, sore-throat and headache.

- They will be quarantined in specific institutions designated by the Ministry of Health until their results are ready.
- iii. Travelers who test positive will be managed according to the national Case Management Guidelines.
- iv. Travelers without fever but with other symptoms will be assessed to determine the need for testing.

6.0 Returning Residents and citizens without symptoms

All **Zambian nationals and returning residents who do not have symptoms will observe mandatory 14-day quarantine at home.** Homes will be inspected beforehand to ensure that the facilities/environment are suitable for home quarantine, contrary to which they will quarantine in designated facilities. They shall monitor themselves daily for development of COVID-19 symptoms and report any such signs to the nearest health authority.

7.0 Business Travelers

- a. **Business travelers coming into the country with a negative SARS CoV2 PCR test are free to conduct their business as planned,** while adhering to recommended COVID-19 prevention measures such as maintaining physical distance, masking and personal hygiene. They shall monitor themselves daily for 14 days for the development of COVID-19 symptoms and report any occurrence to the nearest health authority.
- b. **Business travelers coming into the country without evidence of a negative SARS CoV2 PCR test will not be allowed into the country.**

8.0 Tourists

Tourists coming into the country without evidence of a negative SARS CoV 2 PCR test will not be allowed into the country.
